3 Minutes of the previous meeting

3.1 Approval of the minutes

The minutes were agreed and were duly signed as an accurate record by the Vice Chair. **KT** urged members to submit case studies for the Underwater Noise Guidance.

3.2 Matters arising from the minutes not covered by the agenda

There were no matters arising from the minutes that were not covered by existing agenda items.

4 Changes within ESC The International Marine Contractors Association

The following new members were introduced and welcomed by the committee.

GL, Assistant Technical Adviser – Environment and Sustainability in IMCA.

FS Standards & Innovation Director Bourbon.

5 Board Updates on Scope 3

IG expressed gratitude to the committee members for their time and dedication. He gave Board Feedback on Scope 3 as follow:

- It is recognised that there has to be improved communication and a stronger link between the committees and the board. One role of the new Director of Strategy and Energy Transition is to co-ordinate the interfaces between the GHG, ES and MPRA functions and improve communications.
- The process by which IMCA identify new documents will be better managed in its earlier stages (share synopsis with other committees and the board). Revise IMCA document creation process including using the dashboard, to get board's feedback in early stages.
- IMCA Legal committee input is fundamental and will be solicited in earlier stages of document development when sensitive corporate issues are identified.
- The guidance document will be renamed as informative and less prescriptive.
- Best practices to be renamed as case studies.
- Interpretation of regulations to be removed.

He also mentioned the launch of Future IMCA at Global Summit and urged members to join this great event.

The committee view on the board feedback is noted below:

SC reiterated that the guidance is of high quality, and it targets not only marine companies but multinational companies. He highlighted the need to learn from previous lessons learned within IMCA and be the front runners in environment and sustainability. Also due to the current environmental crisis, it was important that the board leadership comes up to date with environmental and sustainability issues. This was the first year some members were reporting about Scope 3 and there is a lot to learn.

EC was appreciative of **IG** acknowledgment there is going to be more communication and collaboration between committees.

MK asked about **IG**'s strategy for overcoming additional bureaucracy whilst upholding IMCA's governance structure to which **IG** reassured the committee it was the board's intention.

KT enquired about the boards vision for the ES committee, **IG** said that they were focusing on compliance without creating additional regulations unless in regions where regulatory requirements were lower than the IMCA Standards.

AL highlighted that the current landscape is a constant changing environment and there is a need to adapt with time.

Work Group Updates

Supply Chain

PN reiterated what **IG** said about the Scope 3 document. The board comments will be discussed with the Supply chain group on 15th October. The new version of the document will be shared with the ESC members- Nov with a planned release for end of this year.

Life Below Water

JB provided updates as follows:

- Marine Biodiversity Net Gain Document was issued in June.
- There was new revised structure for the Underwater Noise document now chapters include: Background, Legislation, Source of Noise, Impact of underwater noise and Noise Mitigation.
- Call to action to share case studies for noise mitigation with technologies, evidence and visuals of results.

AM enquired if the document with the board and other committees. **MN** confirmed engagement with other committee including MPRA and KPI dashboard which is shared with the operational committee and board. This final document will be shared with the MPRA and Marine Committee for review.

Circular Economy

MN gave feedback on the Circular Economy webinar took place on the 18th of September.

- 56 registered participants and 26 attendees.
- IG CEO of IMCA, Veerle Labeeuw from Circular Flanders and Daniel Biegel from Heerema were guest speakers.
- Recording will be shared.

JV thanked the IMCA secretariat and workgroup members for the webinar preparation. IT issues were highlighted and taken into consideration for future webinars as lessons learned.

SC recognised the good job done with the webinar and the insightful presentations.

6 Committee Strategy

KT outlined the strategy for 2024: - Appendix 1. 2025 Strategy will be discussed in detail.

For 2025 and onwards ESC to use their expertise to develop other technical guidance and keep sharing their knowledge. Moving forward *KT* urged that we need to consider what the committee will look like in the future and

what role should it play in the marine contracting industry. **MN** suggested to use the next meeting for focus strategy planning and discussion. The committee agreed.

7 Tackling Reporting Landscape

JV shared DEME experience with CSRD reporting to which companies are required to report on 2024 in 2025 for the first time. It is complex learning journey with different stakeholders.

DEME in April 2023 undertook a detailed GAP analysis to understand which department needs to be involved.

Key learning points:

- Organisation (governance, project approach, involve auditor at the right time on the right topics).
- Start early with Double Materiality Assessment.
- Provide ample time to convert KPIs to the ESRS KPIs.
- Don't get lost in the details and stay pragmatic.

KT asked about **JV** experience with external consultants for CSRD. **JV** highlighted the importance to have a very well-defined scope and strategic sensitivity within the company and with consultants to make progress.

8 Next In-Person Meeting

Members should think about the next in person meeting, where and when will take place and who will host it for 2025.

Members who would like to volunteer to host the committee should contact GL and MN.

9 Other topics

MN informed members that ES Self-Assessment Tool is ready to launch with the new IMCA website. ES Bulletin will also be launching with the new website and needs input from members.

10 Any other business

A poll will be undertaken to determine which members are attending the IMCA Global summit on the 3-4 December at Utrecht. This is to determine the possibility of having the next ESC meeting in Utrecht (In person/hybrid).
