Rhys Jones provided an overview of the proposal for IMCA's next APAC Regional event to take place in Bangkok, Thailand on the second week of April 2025, and possibility of holding a joint event with ADCI.

5 IMCA Global Summit 2025

Rhys Jones provided an overview of the proposal for IMCA's 2025 Global Summit event to take place in either Singapore or Kuala Lumpur in November of 2025.

Jason Veerasingam outlined his view that Kuala Lumpur was the better option for the following reasons;

- Oil & Gas Hub for APAC Region
- Local presence of Oil & Gas operators
- Lower costs

Darren Brunton outlined his view that Singapore was the better option for the following reasons;

- Singapore as Global Hub
- The historically higher attendance numbers at IMCA events staged in Singapore over Kuala Lumpur
- Recent highly success IMCA Underwater Ships Husbandry and APAC Regional events in October 2024
- Local Government and regulatory authority support

Debbi Garreffa added the following point in support of Singapore as a preferred option;

• Singapore allows direct single flight access from anywhere in the APAC region (unlike Kuala Lumpur) which would assist in boosting regional attendance

Patrick Clift outlined the feedback process for the 2024 IMCA Global Summit and how this would assist IMCA to continue to grow and improve the event in 2025.

Debbi Garreffa asked for it to be noted that she regarded the 2024 IMCA Global Summit as a success and complimented the IMCA events teams on its work.
