4 Objectives and Work Items

- 4.1 Roger Advised committee on new IMCA policy to not record meetings unless that was the wish of the committee, this was to get more people involved in discussions. IMCA only used these internally to assist with accuracy of minutes. Roger highlighted location of previous minutes for new members.
- 4.2 IMCA policy on attendance at meetings was highlighted by Rene and he mentioned the above 3 strikes traffic light system in section 2, whereby if you don't attend for 3 consecutive meetings then this member would be asked to step down.
- 4.3 Round table introductions were heard from all attending to highlight backgrounds of all new committee.
- 4.4 IMCA update was read out by Roger, he highlighted the new website release date of 7th October 2024, as well as date for next operations committee which Rene will attend.

- 4.4 Roger gave an update on the document review process, where these were stored online, access to them and working groups, a lead was then selected for each document.
- 4.5 Roger gave an update on R006, in its new Ecmid format to be online with other departments and outlined the new upcoming ROV System Auditors Scheme and Trainee ROV system auditors course that would start when this document has been completed. It will also mark the start of verified ROV system auditors on the IMCA website similar to Marine and Diving as well as a portal for uploading ROV audits completed so these can be used again and again over the validity term rather than repeating audits for multiple clients. Doug raised a point on question in R006 and had some feedback from an auditor.

4.6 Roger gave an update on R009 Mobilisation document which is also being reviewed. This has lots of comments all ready but needs to be ratified and then republished. Section on remote ops to be added same as we did for R004

- 4.7 Workgroup Leads: Ewan was selected as Lead for R019, Rene was lead on R006, with a workgroup involving Doug Middleton, Graham Russell, Kevin Porter, Mike Leijerzapf assisted by Roger Moore. Darren Shannon agreed to lead R009, with working group of Tommy Adebayo, Sabine Smith, and Tom Baguet.
- 4.8 Rene raised the subject of topic groups and invited anyone to put forward a topic at these meetings. Rene discussed deployment analysis, or analyser's on vessels to assist in the working window. Sabine mentioned that she had seen analyser discussion coming up more and more often, John had also faced issues with this in his companies' operations. Graeme also put forward the question whether we would see a move towards live conditions and monitoring stations in the near future. Deployment analysis is in operation on walk to work and in Norway already (U102).
