

**Minutes** of a meeting of the Association's Health, Safety & Security Core Committee held on 24 July 2024 from 1230 BST via videoconference

### 1 Competition law compliance policy

Previous committee members Erik Bergh (Deepocean), Luke Dicks (Boskalis) and Andre Storbø (DOF), were coopted back onto the committee.

# 2.2 Committee Chair and Vice-Chair

Members discussed who would be Committee Chair and Vice-Chair. It was agreed by all that Darren Male would continue as Chair, and Debbi Garreffa, as Vice-Chair.

# 2.3 Minutes of the previous meeting

The minutes of the meeting of Wednesday 24 April were approved and would be signed by Darren Male who was committee chair at that point.

# 3 Committee objectives

The Chair outlined the committee's objectives, which were dealt with in the headings below.

# 3.1 Human and organisational performance (HOP)

Nick Hough reported that an Information Note had been prepared on this, which was published in May. Members asked how the Information Note had been received. There is growing anecdotal evidence from this committee *[post-meeting note: and from other committees]* that Information Notes were not reaching the attention of those

for whom they were intended – they were not being circulated widely enough. Nick Hough would look into this and discuss internally at the secretariat.

#### Action: Nick Hough

Members agreed that raising the profile of Human and Organisational Performance amongst our members, should continue. What would the next step be? A discussion between the Chair, Nick Hough and Eric Annand (who chaired the workgroup) would be a starting point.

# 3.2 Short Service Employees

Ben Neal reported that a good foundation towards guidance on management of short service employees had already been developed. An improved draft would be available shortly.

# 3.3 "H in HSS" – revision of HSS 033 Guidance on occupational health

Debbi Garreffa reported that the workgroup were three-quarters of the way through the revision of HSS 033 *Guidance on occupational health,* expecting completion in August and publication in September.

# 4 Document review

The following documents are under ISO 9001 review by this committee in this calendar year:

  - Members have kindly amended and commented on this document already, even as the committee election has taken place – many thanks. Nick Hough would finalise this document and arrange with John Kingston at the secretariat for the revised version to be uploaded.

# 5 Safety Flashes

Nick Hough reported that 14 Safety Flashes had been published so far this year, covering 70 individual incidents or events. Hand and finger injuries remained a significant issue. See item 6.

Members discussed various ideas to enhance the look and feel of safety flash material and safety promotional material in general, agreeing that there were opportunities to further enhance the availability, accessibility and usability of Safety Flashes and safety promotional material.

- A Safety Flash App, though off the radar for the present, need not be ruled out for the future;
- Safety posters still had value and ought not be seen as "old-fashioned";
- Who were the intended audience of safety promotional material and safety flash material? It was noted that data was available on download and "hit" rates for safety videos, safety promotional and other IMCA material.

# 6 Safety Statistics

Nick Hough reported that the 2023 safety statistical data from IMCA contractor members was now live and could be seen on the IMCA web at https://www.imca-int.com/data/safety/ and a slide pack (PDF) downloaded from https://imcaweb.blob.core.windows.net/wp-uploads/2024/06/IMCA-Safety-Statistics-2023.pdf.

Jim Cullen reported that IMCA was working closely with the G+ to assist with improving safety across the offshore renewables sector.

There had been submissions from 181 contractors which was around half the contractor membership as of January 2024. There was a discussion of how to increase participation.

# 6.1 Line of Fire LTIs

Nick Hough reported that the IMCA Board sought further detail on Line of Fire LTIs, which have comprised a little less than half of the LTIs recorded by IMCA contractor members in recent years. He noted that of 181 contractor members who shared statistics, 81 members had recorded LTIs, and 54 members' LTIs included Line of Fire incidents. Therefore further information was sought from those 54 members, on what happened in those Line of Fire LTIs. Details of feedback thus far were included in the slide pack.

Members discussed this line of fire safety and hand/finger safety, noting the following:

- How do we ensure at the design stage that people CAN'T GET into the wrong place and harm themselves?
- Where should effort be focussed?
- A "deep dive" focus on individual LTIs may be a worthwhile and beneficial technique;
- Human and Organisational Performance (HOP) links well into this topic.

# 7 Recent and forthcoming events

Nick Hough reported on some recent and forthcoming events including the following:

- 22 May: Equinor's Marine Operations "Safety and Sustainability" (SSU) follow-up videoconference
- 12 Sept IMCA Lifting and Rigging seminar, NL
- 9-10 Oct IMCA Asia Pacific meeting and Underwater Ship Husbandry seminar, Singapore
- 3-4 Dec IMCA Global Summit, Utrecht, NL
- Proposed HSS/C&T seminar for Q1 2025 we will take a steer from the Head of Comms on progressing that.

The **IMCA Global Summit** would take place 3-4 December 2024 at Tivoli Vredenburg in Utrecht in the Netherlands. The theme would be *"Delivering a new offshore energy mix - finding safe and sustainable solutions to meet global ambitions for marine energy."* The agenda is to be finalised, but the current plans are that on day one it will be a predominately business related. And we'll have three streams of the more technical content in day two. There will be a modern and engaging programme planned with keynotes, panel discussions, fire-side chats, workshops and audience Q&As. We'll also be sharing the winners of the IMCA Awards.

Committees were encouraged to hold their Q4 meetings face-to-face after or before the Global Summit.

# 8 Any other business

#### 8.1 Food allergies offshore – discussion

Nick Hough reported that he had been asked by representatives of the G+ to ask this committee about food allergies offshore. Were they an issue? It had been suggested that food allergies were "an upcoming topic as more and more

*people seem to develop severe allergies*". Members discussed this, noting that it did not appear to be a problem for their offshore crews. The following points were noted:

- A rise in picky eating, though not food allergies, had been discerned by some;
- There was a rise in perceived veganism, or at least, crew identifying as vegan, particularly on the offshore wind side. It was suggested that this would be due to a younger workforce;

#### 8.2 Drug and Alcohol positive test issues

It was noted that some members were seeing a recent rise in "positive" tests having detected, not alcohol, but certain medicines including prescription medications. Our members work in many different jurisdictions across the world and differing standards may apply in different locations, as to what is and what is not permitted offshore.

#### 8.3 Security committee

Nick Hough gave a brief update from the most recent security committee. Issues discussed had included crew welfare relating to security, "Virtual" kidnapping, and the possibility of holding the HSS Core committee and Security committees on successive days.

#### 8.4 UXO

Time did not allow for a discussion of this, but it would remain on the agenda for the next meeting.

#### 8.5 Audit for cause

Nick Hough presented a slide on Audits with Cause. IMCA can and will act when evidence of any wrongdoing by members is presented, and reserves the right to audit its members at any time.
