4 IMCA Update

Rhys Jones provided an update of IMCA's event schedule for 2024, focused on IMCA remaining event schedule for 2024 including;

The issue of ticket price at IMCA Global was raised. It was pointed that committed APAC committee members who have and continue to travel and contribute to IMCA work are being questioned internally regarding the cost of attendance at a European Global event. It was considered that given the cost of travel from the Asia Pacific region, IMCA would like to consider the cost of tickets for members of committees based outside of Europe.

The committee asked what contribution to the IMCA Global programme was expected of them. Rhys Jones confirmed that this was coordinated centrally by the IMCA events teams and that potential speakers had or would contacted directly by them, rather than via the TA's and committee members.

Darren Brunton provided an update on planning for the Underwater Ships Husbandry event. The following was confirmed;

- 130 registrations
- Keynote speakers
- The event is free to attend

5 Q3 APAC Regional

Rhys Jones reminded the committee that the event is booked for 9th October 2024 at Marina Bay Sands, Singapore, and presented a draft programme for the event.

Rhys Jones also explained to the committee that we would have Iain Grainger (IMCA CEO), Jim Cullen (IMCA Technical Director) and Bill Chilton (IMCA Diving Manager) in attendance who could be utilised in the programme.

Darren Brunton suggested that APAC regional should, as far as possible reflect the full spectrum of members activities and interests. It was requested that the programme clearly set out which session relate to which IMCA divisions / functions / committees.
