4 IMCA update

4.1 Membership and Committee elections

Roger gave an update on new and current members (178) and number of documents downloaded withing the Survey category (2920) in 2023.

Roger then explained the Committee election process and bylaws section 16, around committee selection and provided links where to locate these, and also responsibilities of the committee and where to find the support documents which should be read and understood by all committee members.

4.2 Other IMCA Committee Updates

Julian Nelson of the C&T Committee provided an update to the Survey Committee. He informed the committee that a proposal had been delivered to the Board to implement an IMCA accreditation scheme for members competence schemes. It is felt that such an initiative would reduce instances of fake IMCA certificates being circulated and provide members with a way to reduce the cost and effort associated with the auditing of their schemes by Clients.

As part of this initiative the C&T committee are requesting support from the other committees. Committee members discussed the initiative and considered various scenarios where members may or may not see value in such a scheme depending on whether they are managing their own scheme, having a scheme managed by a 3rd party or where they may have a requirement to audit competence process of subcontractors. There was no agreement reached to endorse as a Committee during the meeting and it was recommended that members provide feedback to Julian individually.

5 Committee Workgroup Activity

• Revision of IMCA S 003 Multibeam echosounders: some progress made and will aim for March for close out.

• IMCA S011 AUV Guidance (Combined with ROV):, This document was withdrawn some years later as it was regarded as adding little if any value. In recent years, however, it was rediscovered in the secretariat's records and revisited with a view to it being revised and re-published. ROV committee are working on IMCA R004 and once complete will move on to S011. Ian Ellis (3DatDepth) informed Committee that Andy Baker who had been representing the Survey Committee on the workgroup had left his direct employment with 3DatDepth and was now engaged as a contractor. Ian would follow up with Andy to determine if he would continue to represent the Committee on this workgroup.

Revision of IMCA S 013 Deepwater Positioning: workgroup still at chapter 4 because of work load but was
making progress; No change to previous statement- the workgroup would be approaching the main suppliers
soon for technical comments. It was suggested that further useful technical input could be sought from IOGP,
from Total Energies in particular, and from the universities; (Newcastle & Glasgow)

IMCA S017 Guidance on vessel USBL systems for use in offshore survey, positioning and DP operations

IMCA S019- Guidance on Subsea Metrology-

Discussed Introduction on video and laser acceptance criteria, Patchy RMS Values & correlation of overlaying points, also if we needed to bring in someone to QC Photogrammetry calibration. Also guidance on available solutions, working with point cloud & Spool metrology and maybe need to add IOGP Standards. Scott Howden agreed to take over from Simon Barret as lead for the revision of this document.

IMCA S020 Guidelines on Management of Survey and inspection data –

members deemed that this document was still "in date" as it had most recently been reviewed in 2020. So we agreed to extend for 3 years

6 Update from IOGP

Walter Jardine gave a presentation with latest updates on the work activity of the IOGP Geomatics Committee.

Discussion was held on the process around creating the recent IOGP DOCs #624-02 #624-01. These were published in Q4 2023 by IOGP without the awareness or review of the IMCA Survey Committee members. The creation of these documents were supported by members of the IMCA Survey Committee (Simon Barret/Gordon Brown) and IOGP believed that this was sufficient to be considered as being approved by the Committee. Mike Clark explained that due to changes in the Committee structure and Secretariat over the period the visibility of this input by Committee members to the documents had been overlooked. It was agreed that in principal where documents are being developed with the input of IMCA members there should be a short review period for the wider IMCA Survey Committee.

IOGP will be hosting a Webinar to inform the industry on these new documents with a date set as 13th February 24 with a link to be distributed.

Future collaboration between IOGP Geomatics and & IMCA Survey Committees was discussed with topics of potential interest identified as;

- Point Cloud Data from LiDAR/Photogrammetry
- LBL Array Adjustments
- Basic Survey Statistics, Accuracies & Tolerances

General discussions were held around all three topics however no definitive conclusion was drawn as to the document type or content to address each topic. This would need to be continued to be discussed and drawn out by the relevant Committee's.

Ian Ellis suggested that a presentation from i-Tech Services (now Subsea7) to the Hydrographic Society In Scotland in 2018 was a good starting point for discussions on LiDAR/Photogrammetry. Ian would send the document to Roger for distribution to the Committee for awareness.

A meeting has been previously scheduled by Lucy at IOGP for Tuesday 23rd January to discuss areas of collaboration. This is to be attended by Mike Clark with the invitation extended to the rest of the IMCA Survey Committee to attend at their discretion.

Committee objectives were reviewed and agreed to continue from 2023 as above with an end date of March 2024 put in place to show next committee that progress and close out has been done.
