4 Development of a carbon intensity metric for offshore sector

4.1 Regional Approach – Brazil Navy

Captain Fernando of the Brazilian Navy has expressed an interest in collaborating with IMCA on the Spinergie project on a regional basis to assess the alternative Carbon Intensity Metrics proposed by IMCA (i.e. proxies A and B) when adjusted to reflect the operational mode of the vessel and their potential impact on the offshore fleet in Brazil, since notably, the region possesses among the most sizable offshore fleets.

Captain Fernando indicated that, depending upon the outcome of the Spinergie project, Brazil may be willing to cosponsor a paper to the IMO advocating for IMCA's alternative CII. The Chair and V Chair will reach out locally to the Navy and discuss further and organise an informal meeting with IMCA ahead of MEPC 82 scheduled for September 2024 where discussions during will continue.
