Rhys Jones, Maarten De Wit and Gareth Potts provided an update on the revision of IMCA M254 and report on the status of work from the M254 guidance revision editorial group and a an update the wider requirements to further improve safety performance regarding the use of motion compensated gangways.

The group was reminded that revision of the guidance would be the first stage of industry work in this area and further workstreams would be required in 2025, Including but not limited to;

- Competence development aspects (GWO and OPITO have both been engaged to discuss)
- The potential for an incident reporting system
- The potential for operators log books
- Further consideration of telescopic speed reccomendations

The revision of M254 is on schedule and due for completion in 2024.

Construction phase

- Marine coordination
- Subsea noise

Operational phase

- Marine coordination
- DP operations near wind turbines

- Blades (turning, rotating/heading changes)
- Permits
 - Shut down of wind turbine
 - Powerlines
 - Safety training (re: C018)
- Subsea power cables (re: D079)
